
The Map Plan represents the current annexation strategic plan that has been developed and updated by the City. The boundaries of each proposed annexation area represent logical boundaries for the incremental expansion of the City of Florissant. Of course, certain sequencing and/or combination of areas will be necessary in order to meet contiguity requirements.

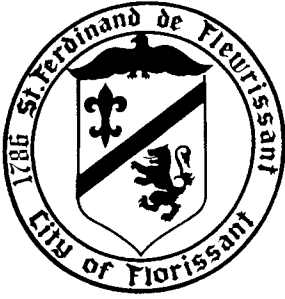


